Benefits of Input Finance Program

- Customer Input Purchases through Skyland Grain are financed at a competitive interest rate until maturity date. No Payments are required until maturity date.
- There is **NO PENALTY** for early payment or payoff.
- The Producer will determine charges submitted to the Input Finance Program with Skyland Grain providing an accounting of charges monthly with the billing statement.
- Input Finance Program Producers are eligible for the Skyland Grain, LLC **FERTILIZER DISCOUNT** when applicable.
